## AN INDIVIDUAL RECOVERED LOST VIDEOS AND DOCUMENTS FROM INACCESSIBLE PARTITION

His Seagate hard disk drive had the model number SRD0SP0, serial number NA5AQP4G, and with the storage capacity of 1 Terabyte.

Mr. Mishra used his hard disk drive to store his digital data. The partition of the storage drive that had become inaccessible lately had important personal videos and other business critical data, which he did not want to lose. ### A FLAWLESS RECOVERY AND REPAIR

- Media was detected, but partition not visible
- Problem in the initial sectors of the affected drive
- Few bad sectors resulted in the partition loss
- Few videos required by client was corrupted too

The same was communicated to Mr. Mishra through email.

After receiving his affirmation for recovery, our engineer at the outset created full image from the defective storage medium. He then used Stellar's powerful data recovery software to scan the created image file. The engineer previewed the partition to assure all is as per expectation. After that he recovered all the data and saved it in Stellar's recovery drive. The process took a substantial amount of time.

On scrutinizing few files, our quality expert found few corrupt videos that do not play.
